02. The tenderer is being permitted to tender the consideration of the stipulations of his part that after submitting his tender, he will not resile from his offer or modify the terms & conditions thereof. In case, the tenderer fails to observe and comply with the foregoing stipulations there tender will be out rightly rejected without assigning any reason. **(A)** The tender form should accompany with E.M.D. as mentioned against each equipment/item. The E.M.D. in the form of DD/Pay Order drawn in favour of the **"ICAR UNIT - DWSR, JABALPUR"**. **(B)** The successful tenderer will be required to deposit 10% security deposit in the form of DD/Pay Order/F.D.R. of total value of the stores as soon as desired by this Directorate i.e. before placing firm order for the supply of stores which will be refunded on successful completion of warranty of the equipment. **(C)** In the event of the offer made by the tenderer not being accepted, the amount of E.M.D. deposited by the tenderer will be refunded to him after he applies for the same in the manner prescribed by the Council/Directorate.
03. If any modification of the schedule is considered necessary, it should be communicated by means of a separate letter alongwith the tender.
05. The tender is liable to be ignored if complete information as required is not given therein or if he is particularly asked for in the schedules to the tender or other documents connected with the contract/tender may specify whether he signs if in the capacity of (i) a sole proprietor (ii) a partner of the firm, if it be a partnership whether by virtue of the partnership in which case he must have authority to refer to arbitration of dispute concerning the business of the partnership whether by virtue of the partnership agreement or power of attorney, or (iii) constituted attorney of the firm if it is a company.

08. The Council/Directorate does not pledge itself to accept the lowest or any tender and also reserves to itself the right of accepting the whole or any acceptance of the tender or portion of the tender. You are, however, at liberty to tender for the whole or any portion or to state in the tender that the rates quoted shall apply only if the tender is considered fully.
09. Fax/letter or any other form of communication will communicate acceptance by the Council/Directorate. Formal letter of acceptance of the tender will be forwarded as soon as possible. But the earlier instruction in the fax/letter etc. should be acted upon immediately.
10. In case of any disputes arising in respect of the said tender the dispute will be solved through arbitration and the tenderers will have to abide by the decision of the arbitrator. The arbitrator will be appointed by the Director General, ICAR, Further, the tenderers will have to submit an undertaking to the effect that they shall agree to the settlements of disputes through such arbitration and they bind themselves/themselves to go by the decision of the arbitrator.
11. The selected agency shall effect the supply of above items within the period of **one month** or as specified in the supply order and no extension of time limit to this effect will be allowed. However, in case of the circumstances beyond the control of contractor, his request for the extension of time can be considered in case the competent authority to grant such extension, viz. Director, DWSR, is satisfied with the circumstances explained by the contractor in his application. ## **SPECIFICATION FOR LC-MS/MS SYSTEM**

A high performance bench top triple quadrupole LC-MS/MS system for herbicide analysis as per EU guidelines with following specification :

### **MS/MS DETECTOR**

1. LC-MS /MS should be a triple quadrupole based system in combination with the linear ion trap provision for quantitative and qualitative analysis in a single run.
2. Provision of high sensitivity full scan MS/MS and MS3 with high selectivity from true triple quadrupole ion and neutral loss scan
3. The system should be capable to trigger MS/MS and MS3 from MRM transition so that the presence and the structure of the metabolites can be confirmed at the same time on a single system.
4. Mass range from 10 da to 1500da (amu) or more.
5. Resolution should be unit mass over the entire range.
6. The mass axis stability should be  $\pm 0.1$  da over 24 hours.
7. The quadrupole should have pre and post RF ion guides.
8. The triple quadrupole analyzer should have femtogram sensitivity.
9. Highly efficient electron multiplier or photomultiplier detector.
10. The system should have electronic pressure and flow control for nebulizing gas, drying gas, auxiliary gas and collision gas.
11. The system should have +/- polarity switching time 100 millisecond or less.
12. The system should have dual stage turbo molecular pump of at least 300/400 L/s for Nitrogen.
13. The API interface should have three axis adjustment of electrospray needle.
14. The API interface should have an off-axis quadrupole ion guide and should have provision to clean the source without venting the vaccum.
15. Source should be Programmable and automatically switchable from ESI to APCI in a single run.
16. The LC flow range for ESI should be from 1 to 1000  $\mu\text{L}/\text{min}$ .
17. The ESI Needle voltage should be settable to more than 5000 V.
18. The flow range APCI approximately from 10 to 2000  $\mu\text{L}/\text{min}$ .
19. The system should have built in syringe pump and auto tune facility.
20. +ESI SIM : 50 pg reserpine S/N  $\geq 4000 : 1$ , based on RMS noise.
21. +ESI MRM (MS/MS) : 50 pg reserpine S/N  $\geq 4000 : 1$ , based on RMS noise.
22. Others :
  - System should be supplied with suitable low noise and vibration free gas generator to provide the gases required to operate the system.

Liquid chromatography system should be compatible to the above MS/MS system.

3. Vaccum degassing provision for each chromatographic and wash solvents.
4. Flow rate should be from 1.0  $\mu\text{L}/\text{min}$  to 2000  $\mu\text{L}/\text{min}$  (1 $\mu\text{L}/\text{min}$  increments).
5. The flow accuracy should be  $\pm 1.0\%$  or less at 0.5 mL/min with methanol.
6. The Maximum pressure limit should be 9000 psi or more.
7. Integral provision of plunger seal wash.

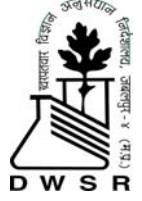
